- Expands and enhances procedures including hernia repairs, prostatectomies, and gynecological procedures.
- 80% of laparoscopic surgical procedures have converted to the robotic platform.
- Leads to stronger recruiting of HRRMC physicians.
- Provides greater access to healthcare in our 8,000 square mile region.
- Improved health outcomes.



The DaVinci 5 (DV5) was delivered to HRRMC on June 30! On August 29, after set-up and training, the first robotic surgery case in Salida took place. Two new general surgeons also joined HRRMC: Dr. Zachary Green and Dr. Stefan Iverson, both trained in robotic surgery.

HRRMC Foundation, in partnership with HRRMC, is raising funds for the Robotic Surgery Program. HRRMC Foundation hosted a DV5 demo for donors and community officials in August and at the 2025 Jewel Ball on October 2. To date, the Foundation has raised \$167,000. Congratulations Dr. Bruce Gross - 2025 Hall of Fame Honoree

For over 25 years at HRRMC, Dr. Bruce Gross was the "calm" in the emergency department. He was the steady thread that started as a small town emergency room with four beds at the old hospital on First Street, continued into a certified Regional Trauma Center, and bridged into a steady Emergency Department at the new hospital campus in 2008.

Through this period of significant growth and evolution, Dr. Gross provided steady and compassionate leadership to the ED and outlying partners. This included his service as Medical Director for Chaffee County Emergency Medical Services.

Dr. Gross began working regularly on medical mission trips to third world countries early in his career. For over 35 years he cared for the underserved in Thailand, Burma, Central America, and South America. It was an important part of his own health and recovery as he found balance from a busy primary care practice.

Dr. Gross retired in 2021 and was inducted into the HRRMC Hall of Fame in October 2025.

MARY ANN BANACH WOUND CARE CENTER to open mid-year 2026!
