HRRMC Cash-based Rehab Services

Easy to access, affordable care

What are cash-based Rehab services?

HRRMC is focused on providing affordable, accessible healthcare to our community. Cash-based services offer a more affordable alternative for those with a high deductible insurance plan or limited or no insurance.

- An HRRMC financial counselor will meet with you up-front to compare your insurance coverage with cash-based pricing.
- With cash-based services, you pay a reduced rate in full at the time of service.
- There is no insurance billing.
- Cash-based services will not be applied to your insurance deductible.
- If you decide to use cash-based services and then switch to insurance coverage, you may have to pay for a second “initial evaluation,” to meet the requirements of the insurance company.
- If you decide to switch from insurance coverage to cash-based pricing, you may not switch back again to insurance coverage.

What Rehab services are available for cash-based pricing?

- **Physical Therapy** including dry needling, lymphedema therapy, neurologic therapy (for strokes, Parkinson’s, brain injury), orthopedic therapy, pediatric therapy, pelvic-floor PT and vestibular (dizziness) therapy
- **Occupational Therapy** including hand therapy and ergonomic assessments
- **Speech Therapy** for children and adults

Why are cash-based prices less than those billed to insurance companies?

There is no billing of patients or insurance companies, which reduces HRRMC’s costs. HRRMC can pass those savings on to you.

Can HRRMC bill insurance for a cash-based rehab visit?

No. HRRMC will not bill insurance or any third-party payers for cash-based visits. HRRMC accepts cash, check or credit cards up front, at the time of service.

Will my insurance company reimburse me for the cost of the visits?

No. The information required by insurance companies is not available through cash-based services.
